New Members Joining our VC CORE Team

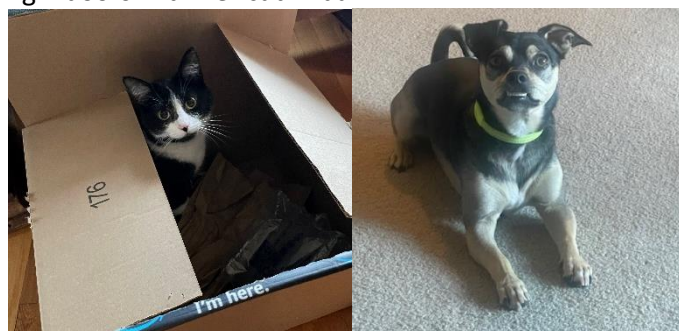
Our VC CORE is excited to introduce our new teammates Saige Calkins and Kayla Gray! Please join us in welcoming them to our team and the broader HSR group!

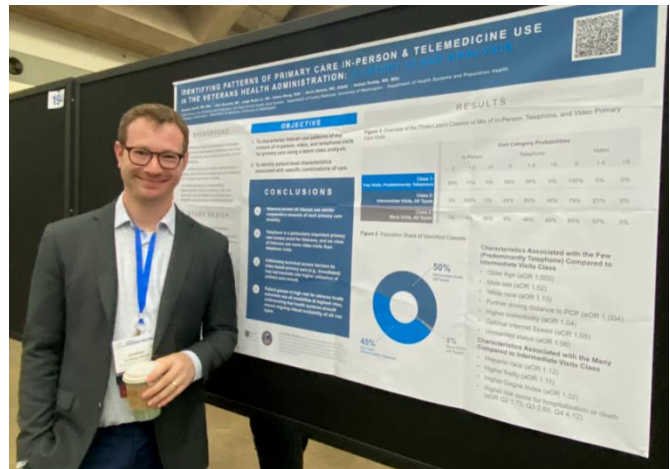
